

## **ANNEXURE 'A':**

Nominations are hereby invited for **One (1) post of Vice President (2025-2026) cum President Elect (2026-2027) and One (1) post of Executive Committee Member (2025-2028).**

## **RULES & REGULATIONS:**

Any Life Fellow Member of IPS-WZB may send his nomination (form enclosed as *annexure 'B' below*) as per the Article-V, Clause 17 of the constitution of IPSWZB. Article-V, Clause-17 is read as under.

1. Any fellow of the IPS-WZB may be nominated for election of Vice President cum President elect. The fellow nominated for the office of Vice President-cum President Elect must be a life fellow of the IPS for at least 10 years, and must have served the Zone at least for one full term as a member of EC. The Life Fellow nominated for the post of Hon Zonal Secretary must be life fellow of IPS for at least 5 years, and must have served the Zone at least for one full term as a member of EC.
2. A Life Fellow can propose or second only one candidate for one particular Post. The Life Fellow nominated must express his/her consent in writing to be nominated for the said post.
3. A brief bio data of the nominee of not more than 100 words must be sent along with the nomination.
4. The nomination must be sent in a password protected scanned PDF document on which "**Nomination**" shall be mentioned (in subject of email). If a particular life fellow member filling more than one nomination for different posts, they should send the nomination in separate email.
5. The nomination should reach to **Dr. Vivek Kirpekar** (Chairman, Election Commission, IPS-WZB) at email address – [electioncommission@ipswzb.in](mailto:electioncommission@ipswzb.in) on or before **5<sup>th</sup> August 2025**.

6. THE COMPLETED NOMINATION FORM (ANNEXURE 'B') SHOULD BE SCANNED AND CONVERTED TO PDF FORMAT. THIS DOCUMENT SHOULD BE PASSWORD PROTECTED BY THE NOMINEE. THE PASSWORD SHOULD NOT BE SENT IN THE EMAIL. THE SAME WOULD BE ASKED FROM THE CANDIDATE DURING THE SCRUTINY MEETING AND THEN THE DOCUMENT WILL BE OPENED IN PRESENCE OF OFFICE BEARERS/EC MEMBERS PRESENT IN THE SRUTINY MEETING.

7. There will be Special Scrutiny Meeting on **15<sup>th</sup> of August 2025**, where these nominations will be scrutinized by Election commission.

8. Election Commission will inform the Scrutiny Report to all nominees by **20th August 2025 by Email/SMS.**

9. If valid nominations are more than the declared number of posts against any office, then the nominees will be informed about it. The last date of withdrawal will be **30<sup>th</sup> of August 2025** if anybody wishes to do so.

10. Even after the withdrawal, if there are more than the declared numbers of posts against any office, if election is required, then e- voting will be taken. The information will be sent to all the life fellow members through mail & uploaded on website.

**11.**Final list of Contestants will be uploaded on website by **31st August 2025.**

**12.**Email and message for E-voting will be sent by **15th September 2025.**

**13.**E-voting will begin on **16th September 2025 10.00 am.**

**14.**E-voting will end by **30th September 2025 5.00 pm.**

15.Counting of E-votes will be done in the morning hours on the day of AGBM. Date, Time and Venue will be informed prior to the meeting.

16.Results will be declared by CEC at AGBM on invitation by chairperson of AGBM at Nagpur during annual conference of IPSWZB.
